



Protocol for Content Review Sessions, 2019-20

In order to best (and most effectively) support Advance Kentucky teachers and students, Advance Kentucky Content Review Sessions (CRS) are tailored to align with the current geography and enrollments of active schools.

Pre-AP Exam Session

AP MSE students from program schools are invited to attend a content review session in the spring, close to the dates of administration for the AP exams. These sessions will be scheduled by Advance Kentucky staff, will be geographically distributed, and will encompass four blocks (75 minutes each – English will have two sessions per block) with the goal of reviewing/synthesizing important topics in each AP MSE course.

- Specific topics will be determined by the AdvKY directors, in consultation with the classroom teachers, utilizing the student performance on the mock exams.
- AdvKY will provide consultants, food, and swag to attending students.
- Host school teachers are responsible for site arrangements.
- Guest school teachers are responsible for travel arrangements.

Prior Supplemental Activities

Advance Kentucky supports supplemental instructional activities through the academic year. These activities are tailored by content area (math, science, English) as follows.

- **AP English Language and AP English Literature**

Fall sessions for AP English courses are scheduled regionally. Any active Advance Kentucky school may register to attend any session. Fall sessions will encompass an overview of the course and exam description, the AP exam, and key skills needed to be successful in the class and on the exam.

- **AP Mathematics (Statistics, Calculus AB, Calculus BC, Computer Science A, Computer Science Principles) courses.**

Teachers (in collaboration with administration) are invited to schedule through the Advance Kentucky Math and Computer Science Content Directors (Mathematics – Aaron Timmons (atimmons@kstc.com) , Computer Science – Monique Rice (mrice@kstc.com)) up to four blocks of supplemental activities/instruction throughout the academic year.

- Sessions should encompass two blocks (75 minutes each block), and may be scheduled on weekends, after school, on professional development days, on “field trip” days, or any other available times.
- Sessions may be scheduled by individual AP MSE class, MSE department within an active school, school-wide, or regionally.
- Administrators/teachers must request a CRS at least three weeks in advance of the proposed date to allow time to engage a presenter.
 - AdvKY content director will engage and confirm a presenter as quickly as possible.
 - AdvKY will provide swag, reimbursement for snacks.
 - Host school will provide facilities.
 - Specific topics will be determined by participating teachers and the presenter, in consultation with the AdvKY content director.
 - Teachers are responsible for attendance. Anticipated attendance must be the greater of 10 students in any subject or 75% of enrollments. Smaller classes are encouraged to seek to combine with classes in proximate schools. If no proximate courses are available, please consult with the Advance Kentucky content director.

- **AP Science (Biology, Chemistry, Environmental Science, Physics1,2,C) courses**

Teachers (in collaboration with administration) are invited to schedule through the Advance Kentucky Science Content Director (Lew Acampora, lacampora@kstc.com) up to six blocks of supplemental activities/instruction throughout the academic year.

- Sessions should encompass two to four blocks (75 minutes each block), and may be scheduled on weekends, after school, on professional development days, on “field trip” days, or any other available times.
- Sessions may be scheduled by individual AP MSE class, MSE department within an active school, school-wide, or regionally.
- Administrators/teachers must request a CRS at least three weeks in advance of the proposed date to allow time to engage a presenter.
 - AdvKY content director will engage and confirm a presenter as quickly as possible.
 - AdvKY will provide swag, reimbursement for snacks.
 - Host school will provide facilities.
 - Specific topics will be determined by participating teachers and the presenter, in consultation with the AdvKY content director.
 - Teachers are responsible for projecting/ensuring attendance. Anticipated attendance must be the greater of 10 students in any subject or 75% of enrollments. Smaller classes are encouraged to seek to combine with classes in proximate schools. If no proximate courses are available, please consult with the Advance Kentucky content director, Lew Acampora.
